F.SRC/NCTE/2009/B.Ed./RO/14786 dt.24.07.2009 run by Christabel Educational Trust, Poonnamallee Taluk, Tiruvallur District, TamilNadu for conducting B.Ed. course of one year duration with an intake of 100 students from the academic session 2009-2010.

AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by a notarized affidavit dated 27.01.2015 consented to come under new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 17.03.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 for two basic units of 50 students from the academic session 2015-16 with a condition to maintain.

**AND WHEREAS**, SRC in its 384<sup>th</sup> Meeting held on 12<sup>th</sup> & 13<sup>th</sup> February 2020 (P-686-687/Coors.) the matter was placed before the Committee and decided to issue Final Show Cause Notice.

**AND WHEREAS**, as per directed a Final Show Cause Notice was issued to the institution on dt. 21.02.2020.

AND WHEREAS, the institution has submitted written representation on dt. 03.06.2020.

**AND WHEREAS**, the compliance submitted by the institution on dt. 03.06.2020 and the matter was considered by the SRC in its 394<sup>th</sup> Meeting held on 27<sup>th</sup> & 28<sup>th</sup> January 2021 as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Good Shepherd College of Education, Christabel Educational Trust, Periyapalayam High Road, Kasuva, Pakkam, Tirunindravur, Thiruvallur – 602024, TamilNadu for B.Ed. programme for 2 basic units of 50 students each unit."

NOW THEREFORE, the SRC decided to permit the institution i.e., Good Shepherd College of Education, Survey no. 4/1B,4/2,4/3A, 4/3B, 4/4, Periyapalayam High Road, Kasuva Pakkam Village, Panchayat, Tiruvallore District, Tamilnadu-602024 for B.Ed. course run by Christabel Education Trust, No. 5, Dr. Radhakrishnan Street, Charles Nagar, Pathabiram, Chennai, Tamilnadu-600072 for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

The institution shall comply with the various other norms and standards prescribed II.

in the NCTE Regulations, 2014 as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the III. examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff duly IV. approved by affiliating body for conducting the course should always remain in position.

The institution shall ensure that the required number of academic staff duly V. approved by affiliating body for conducting the course should always remain in

position.

- Further, the institution is required to fulfil all such other requirements as may be 9. prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter - alia, the details of the institution, its locations, 11. name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned.
